- Acknowledges that he is legally responsible for the rented equipment, from the time the equipment is taken over at the beginning of the rental, and until the return of this equipment to Narval Sports Passion which corresponds to the end of the rental.
- Commits to return the equipment in the same condition as when he/she received it and to clean it. In case of excessive dirt, Narval reserves the right to charge a unique fee of CHF 70.- for cleaning.
- Commits to pay the amount for repair, intervention or replacement of the equipment in the event of a disaster and according to its liability concerning loss, theft or damage of the equipment. In the event of loss or theft, 90% of the new value of the equipment will be charged. If repair is feasible, Narval will charge in addition to the cost of repair, 20% of the new value of the equipment, since it is no longer saleable at regular price.
